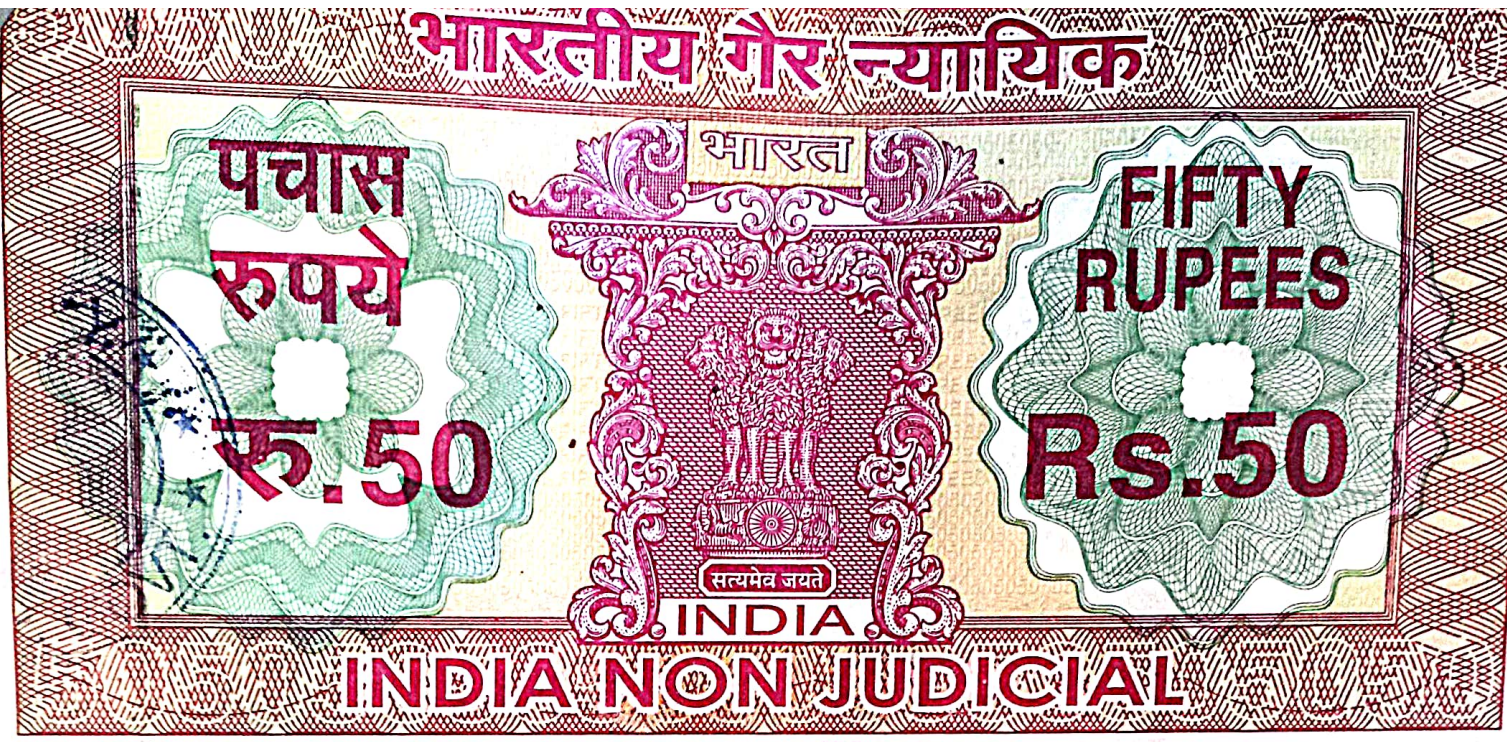

- Mr. Santosh Agarwal Principal of Govt. Inter Collage, Bhandar
 - Mrs. Asha Mishra Teacher of Govt. Inter Collage (H.S.S. No.2), Datia
- 3) The term of the members of the management committee shall be three year. A member can be re nominated for another term but a member cannot remain in office for more than the duties, Powers and responsible of the school managing committee shall be as follows and it shall function subject to the Control and in accordance with the policy to the society/trust. The management committee decide to open an account of any nationalized bank. The account shall be operated by two person vice chairman and principal of the school. This maximum amount Drawn by principal will be Rs. 5000.00 (five thousand only) alone if more amount is required then the above amount with both person's signatures required.
